BOOTH RESERVATION OPEN: MARCH 26nd, 2019

1. All Vendors may reserve any available booths, starting Friday, March 26nd 2019 at 8:00AM, on a “first come, first served” basis.
2. A deposit of half the full amount must be made payable to CALISHINE IMPORT PRODUCTION on the day of your reservation to reserve your booth(s):
 - a. Mail-in DEPOSIT must be postmarked on the day of your reservation.
 - b. Walk-in DEPOSIT must be received by 6:00PM on the day of your reservation.

MERCHANDISE VENDORS
FINAL PAYMENT DUE: JUNE 15th, 2019

1. Final payment must be made payable to CALISHINE IMPORT PRODUCTION by the due date June 15th, 2019.
 - a. Mail-in PAYMENT must be postmarked by June 15th, 2019.
 - b. Walk-in PAYMENT must be received by 6:00PM on June 15th, 2019.
2. If CALISHINE IMPORT PRODUCTION does not receive your final payment, then CALISHINE IMPORT PRODUCTION reserves the right to release your booth(s) to the next Vendor.

Note: A vendor may have up to two booths. There is no cleaning fee, but vendor will be cited and fined for dumping waste improperly or causing damages to any property of the Fairgrounds or CALISHINE IMPORT PRODUCTION. Vendors may purchase additional parking permits at \$10 each and workers badges at \$15 each.

SPONSORED BEVERAGES & GOODS -

CALISHINE IMPORT PRODUCTION reserves the rights to implement the sale of Sponsored beverages and/ or goods during the "ECON 2019".

CITATION & FINE -

Vendors are prohibited from dumping waste improperly or causing damages to any property of the fairgrounds or CALISHINE IMPORT PRODUCTION. Vendors must clean their booth on a daily basis. All trash, food waste and liquid waste must be placed in the appropriate receptacles. At the end of the day of the event "ECON 2019", Vendors are required to leave each of their booths as they found it. CALISHINE IMPORT PRODUCTION staff shall monitor final cleanup efforts by the Vendor and assess the booth area for compliance. Vendor will be cited and fined for noncompliance.

APPLICATION DISCOLSURE -

1. CALISHINE IMPORT PRODUCTION reserves the right to deny any application with or without reason.
2. Vendor must provide a copy of a valid Identification Card to reserve booth(s).
3. Applicant and Co-applicant have the same vendor responsibilities.
4. The information on this application is confidential and shall only be used for CALISHINE IMPORT PRODUCTION purposes.

MERCHANDISE VENDOR AGREEMENTS

PAYMENT

1. Merchandise Vendors must make a deposit to reserve their booth(s)
2. Merchandise Vendors must make a full payment by the dates stated in this agreement.
3. All payments must be made by cash, money order or cashier's check **payable to CALISHINE IMPORT PRODUCTION.**
4. **NO** cash or personal checks shall be accepted.

REFUND POLICY

1. Deposits and Payments are NON-REFUNDABLE after May 31st, 2019.
2. All cancellation refund requests must be submitted in writing, explaining the reason for cancellation.
 - **Before May 31st 2019** – CALISHINE IMPORT PRODUCTION reserves the right to retain %50 of deposits.
 - **After May 31st 2019** – **NO** refunds shall be issued.

VIOLATIONS

1. Merchandise Vendors may be removed, fined, and/or penalized for behaving in a manner deemed to be inappropriate, disruptive, unsafe, disorderly, or illegal by CALISHINE IMPORT PRODUCTION, Fresno Fairgrounds, Fresno Police Department, and Fire Marshall. Vendor shall forfeit their deposit, payment, and fees associated with their booth(s).
2. Merchandise Vendors are **PROHIBITED** from selling weapons, dangerous tools, unlicensed goods, prescription medicines, illegal products, and the like as determined by CALISHINE IMPORT PRODUCTION or by government agency.
3. CALISHINE IMPORT PRODUCTION reserves the right to determine whether an item is considered inappropriate or offensive and to prohibit the sale/display of such an item.

BOOTH SAFETY & WATHER

1. All items being sold or displayed must be contained inside the booth space (including all water barrel anchors, poles, ropes, tables, etc.) with a secure canopy that can withstand wind, rain and other inclement weather.
2. This is an outdoor event. It shall not be cancelled due to wind, rain, or other inclement weather unless ordered by a governmental agency for public health and safety reasons.

ELECTRICITY

1. It is the sole responsibility of the Merchandise Vendors to provide their own power source to operate their own equipment.
2. All items connected to Fairgrounds power source must be 3 wire grounded.
3. Vendors must not use so much electrical power that it will overload the circuits.
4. Electric appliances such as coffee pots, space heaters, hot plates, refrigerators, and microwaves which are intended for the personal convenience of exhibitors and their staff **ARE NOT PERMITTED.**

NOISE CONTROL

1. Radios, television sets, loud speakers, amplification systems, musical instruments, etc., must be controlled so as not to interfere with other Vendors.
2. The use of amplification systems is a privilege.
3. You will get 1 (one) warning, next warning and you will be banned from playing music in your booth/stand.
4. All speakers must be in the rear of the booth or stand pointing down towards the ground and volume must remain at the level designated by CALISHINE IMPROT PRODUCTION reserves the right to revoke your privilege of using any sound devices at any time.

SAFETY & SECURITY

- 1. CALISHINE IMPORT PRODUCTION shall provide security guards and police officers to enforce safety during the "ECON 2019" event.
- 2. All Vendors are responsible for their property, equipment, and merchandise and should not leave valuable properties unattended.
- 3. CALISHINE IMPORT PRODUCTION is not responsible for any damaged, lost, or stolen properties at this event. We cannot guarantee security.

VENDOR PARKING

- 1. All Vendors are required to display/show their Vendor Parking permits for entry at the designated vendor gate(s). CALISHINE IMPORT PRODUCTION reserves the right to refuse entry if the Vendor does not have/display the appropriate parking permit.
- 2. Vendors shall park their vehicle in designated areas only.
- 3. Vendor re-entry may be restricted due to pedestrian safety and limited parking.
- 4. Vendor parking permits must be displayed and visible from the outside when parked.
- 5. Additional parking permits may be purchased at the CALISHINE IMPORT PRODUCTION office prior to the event.

- 2. Vendor agrees to comply with CALISHINE IMPORT PRODUCTION policies, requirements, rules, regulations, and that of any governmental agencies for health and safety purposes.
- 3. Vendor shall assume all risks in the use and operation of his/her booth(s) and therefore shall take all necessary precautions to protect persons and properties from damage, injury, or death.
- 4. Vendor hereby agrees to indemnify and hold harmless CALISHINE IMPORT PRODUCTION and the Fresno Fairgrounds from all claims, liabilities, losses, damages, and injuries as a results of the Vendor's use and operation of any booth.
- 5. CALISHINE IMPORT PRODUCTION is not liable for any losses due to natural disasters, criminal activities, and/or negligent acts.
- 6. CALISHINE IMPORT PRODUCTION reserves the right to cancel this Agreement at any time if it is deemed by any governing agencies that any of Vendor's conducts, goods, and/or services is harmful, unlawful, or unsafe.
